2015 AUTHORIZING RESOLUTION FOR THE EXECUTION OF AN APPLICATION TO CONSTRUCT/MODIFY/OPERATE A PUBLIC WATER WORKS FACILITY FOR BLOCK 64, LOTS 1 AND 4, 192 BLOOMFIELD AVENUE-WATERMAIN EXTENSION

WHEREAS, George D. Cascino, P.E., P.P., on behalf of the developer, 192 Bloomfield Avenue, LLC, hereafter referred to as "the Applicant," is making an application to the New Jersey Department of Environmental Protection (NJDEP), Division of Water Supply & Geoscience to modify the Bloomfield water system through construction of a watermain extension related to the construction of a 336-unit residential development with 38,659 square feet of retail space at 192 Bloomfield Avenue, also known as block 64 , Lots 1 and 4 on the Bloomfield Township Tax Maps ; and

WHEREAS, this modification requires that the Applicant file an application for a permit to construct/modify/operate public water works facility with the NJDEP; and

WHEREAS, this application requires a certification by a representative or representatives of the Township of Bloomfield under sections 6 and 7 of NJDEP Form BWSE-APPLICATION PA 01; and

WHEREAS, the plans and application materials were reviewed and approved by the Township Engineer and Township Water Operator and were found to be acceptable.

NOW, BE IT RESOLVED, by the Mayor and Township Council that the Township Engineer is hereby authorized to execute form BWSE-APPLICATION PA 01 under Section 6 and the appointed Township Water Operator is hereby authorized to execute form BWSE-APPLICATION PA 01 under section 7, as well as any other documents related to this application.
