**2015 ACTION ITEM DISCUSSION**

**MOON PALACE AGREEMENT**

**WHEREAS**, on or about October 18, 2014, November 1, 2014, and January 17, 2015, Moon Palace, Inc. was served with a Notice of Charges alleging certain violations of their Liquor license stemming from incidents that occurred on or about August 3, 2014, October 17, 2014, and November 19, 2014, respectively; and

**WHEREAS**, Moon Palace had a hearing on Monday, February 9, 2015, regarding the allegations in the Notice of Charges; and

**WHEREAS**, Moon Palace has pleaded "non volt" to said charges and has agreed to a thirty day (30) suspension, this suspension shall commence thirty days from the date of the passing of this resolution and shall run for thirty consecutive days thereto; however, license holder shall be afforded the right to file a Notice of Petition and Appeal for Fine in Lieu of Suspension with the New Jersey State Division of Alcoholic Beverage Control;

**WHEREAS**, and all previous restrictions on said liquor license shall remain;

**WHEREAS**, if the business owner decides to sell this liquor license any such conditions shall not be transferred to the new buyer.

**NOW, THEREFORE, BE IT RESOLVED**, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, hereby agrees that Moon Palace's Liquor license 0702-33-020-005 is hereby suspended as stated in the above.

**BE IT FURTHER RESOLVED**, that the conditions described above are hereby placed on Moon Palace's Liquor license.
