**2015 RESOLUTION APPROVAL**

**REJECTION OF BIDS FOR THE COLLINS HOUSE STABILIZATION - PHASE 1**

WHEREAS, after the required legal advertising was published, sealed bids were received in the Council Chambers of the Municipal Building, Bloomfield, New Jersey on February 4, 2015 by the Purchasing Committee of the Township of Bloomfield in accordance with N.J.S.A. 40A:11-1 et seq., "Local Public Contracts Law" for the Collins House Stabilization - Phase 1; and

WHEREAS, a single bid was received from Tec Con Contractors, Inc., 9 Dodd Street, East Orange, NJ, in the amount of \$100,800.00 and referred to the Township Engineer for review; and

WHEREAS, the contract price was above the engineers estimate of \$50,000.00; and

WHEREAS, it is the recommendation of the Township Engineer that the single bid be rejected and the project re-bid in an attempt to acquire additional bid submissions and pricing; and

WHEREAS, the Mayor and Council hereby accepts the recommendation of the Township Engineer to reject bid received and re-bid the project.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey hereby rejects the single bid for the Collins House Stabilization - Phase 1, and authorize the Township Engineer to re-bid the project.
