**2015 RESOLUTION APPOINTMENT**

**TEMPORARY STAFF - BLOOMFIELD MUNICIPAL COURT (Carribon-Baptiste)**

**WHEREAS**, the Township of Bloomfield's Municipal Court needs to hire part time temporary employees; and

**WHEREAS**, Leona Carribon-Baptiste has indicated a willingness to perform the necessary service at an hourly rate of \$15.00 per hour; and

**WHEREAS**, the Court Administrator and Township Administrator recommends appointing Leona Carribon-Baptiste as a part time temporary employee; and

**WHEREAS**, Leona Carribon-Baptiste recognizes that she will not receive health benefits as a part time temporary employee and she shall not work more than 20 hours per week; and

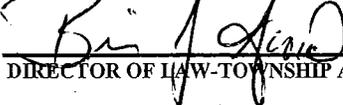
**WHEREAS**, the Director of Finance has indicated that funding is available for this position.

**NOW, THEREFORE, BE IT RESOLVED**, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, that effective January 16, 2015, Leona Carribon-Baptiste is hereby hired as a part time temporary employee at the rate of \$15.00 per hour, not to exceed 20 hours per week; and

**BE IT FURTHER RESOLVED**, that this temporary appointment will terminate six months after the start date without any further action by the Mayor and Council.
