2015 RESOLUTION APPOINTMENT

TEMPORARY STAFF - BLOOMFIELD MUNICIPAL COURT (Jones)

WHEREAS, the Township of Bloomfield's Municipal Court needs to hire part time temporary employees; and

WHEREAS, Aimee Jones has indicated a willingness to perform the necessary service at an hourly rate of \$15.00 per hour; and

WHEREAS, the Court Administrator and Township Administrator recommends appointing Aimee Jones as a part time temporary employee; and

WHEREAS, Aimee Jones recognizes that she will not receive health benefits as a part time temporary employee and she shall not work more than 20 hours per week; and

WHEREAS, the Director of Finance has indicated that funding is available for this position.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, that effective January 14, 2015, Aimee Jones is hereby hired as a part time temporary employee at the rate of \$15.00 per hour, not to exceed 20 hours per week; and

BE IT FURTHER RESOLVED, that this temporary appointment will terminate six months after the start date without any further action by the Mayor and Council.
