2015 RESOLUTION AWARD OF CONTRACT

AUTHORIZING THE 2015 AWARD OF A NON-FAIR AND OPEN CONTRACT FOR TOWNSHIP SECURITY CAMERA HARDWARE AND SOFTWARE SUPPORT SERVICES WITH PROACTIVE TECHNOLOGIES

WHEREAS, the Township of Bloomfield needs the services of professional support of their CCTV Security system throughout the Township; and

WHEREAS, the Township desires to make this appointment under the provisions *N.J.S.A. 19:44A-20.5*, as a non-fair and open contract; and

WHEREAS, the Township IT Director has determined that the value of these services will not exceed \$17,500; and


WHEREAS, PROACTIVE TECHNOLOGIES has provide the attached contract indicating they are willing to provide the services, and has completed and submitted the attached Business Entity Disclosure Certification which certifies that he has not made any reportable contributions to a political or candidate committee in the Township of Bloomfield in the previous one year, and that the contract will prohibit PROACTIVE TECHNOLOGIES from making any reportable contributions through the duration of this contract; and

WHEREAS, the Director of Finance has certified that funds are available to cover the cost of this service:


BE IT FURTHER RESOLVED, that the above documents shall be available for public inspection at the office of the Township Clerk during regular business hours; and

BE IT FURTHER RESOLVED, that in accordance with Standardized Submission Requirements the Township reserves the right to cancel this contract upon thirty (30) days notice and the Professional shall only be paid for the work completed or on a pro-rated amount if the contracts calls for a monthly retainer; and

BE IT FURTHER RESOLVED, that a notice of this action shall be printed once in the official newspaper of the Township of Bloomfield.
