2015 RESOLUTION AWARD OF CONTRACT

AUTHORIZING THE 2015 AWARD OF A NON-FAIR AND OPEN CONTRACT FOR TOWNSHIP TIME CLOCKS HARDWARE AND SOFTWARE SUPPORT SERVICES WITH KRONOS CORP.

WHEREAS, the Township of Bloomfield needs the services of professional support of their time clock system throughout the Township; and

WHEREAS, the Township desires to make this appointment under the provisions *N.J.S.A. 19:44A-20.5*, as a non-fair and open contract; and

WHEREAS, the Township Administrator has determined that the value of these services will exceed \$17,500; and


WHEREAS, Kronos Corp., has provided the attached contract indicating they are willing to provide the services and has completed and submitted the attached Business Entity Disclosure Certification which certifies that he has not made any reportable contributions to a political or candidate committee in the Township of Bloomfield in the previous one year, and that the contract will prohibit Kronos Corp. from making any reportable contributions through the duration of this contract; and

WHEREAS, the Director of Finance has certified that funds are available to cover the cost of this service.

NOW, THEREFORE, BE RESOLVED, that the Mayor and Council of the Township of Bloomfield authorizes the Township IT Director to enter into the attached contract with Kronos Corp. as described herein; and

BE IT FURTHER RESOLVED, that the above documents shall be available for public inspection at the office of the Township Clerk during regular business hours; and


