2015 RESOLUTION AWARD OF CONTRACT

AUTHORIZING THE TOWNSHIP TO USE THE TELECOM SERVICES WITH COMCAST FOR YEAR 2015

WHEREAS, the Township IT Director has determined that the value of these services will exceed \$17,500; and

WHEREAS, Comcast has provide the attached contract indicating they are wilting to provide the services and, has completed and submitted the attached Business Entity Disclosure Certification which certifies that Comcast has not made any reportable contributions to a political or candidate committee in the Township of Bloomfield in the previous one year, and that the contract will prohibit Comcast from making any reportable contributions through the duration of this contract; and


WHEREAS, the Director of Finance has certified that funds are available to cover the cost of this service.
