2015 ORDINANCE AMENDMENT

AN ORDINANCE TO AMEND CHAPTER 254, "VEHICLES AND TRAFFIC", ARTICLE VI SCHEDULE, § 254-63. "Snow Emergency No-Parking Areas"

BE IT ORDAINED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

Section 1. Chapter 254 "Vehicles and Traffic", Article VI , "Schedules", § 254-63, "Snow Emergency No Parking areas", of the Code of the Township of Bloomfield, County of Essex, State of New Jersey, is hereby amended by the addition of the following:

New St.	Entire length

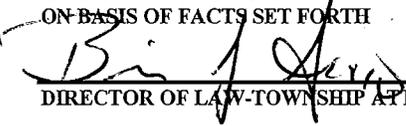
Section 2. All ordinances inconsistent herewith are hereby repealed.
