2015 ORDINANCE AMENDMENT

AN ORDINANCE TO AMEND AND SUPPLEMENT CHAPTER 387 OF THE BLOOMFIELD TOWNSHIP CODE, PROVIDING PARKING FOR PHYSICALLY LIMITED PERSONS

BE IT ORDAINED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

Section 1. Chapter 387, entitled: "PARKING FOR HANDICAPPED", Section 387-4A "Enumeration of restricted parking areas", of the Code of the Township of Bloomfield is hereby amended by the addition of the following:

(483) Mill Street, east side starting at a point 325 feet south of the southern curb line of Pettit Street and running 20 feet south therefrom (78 Mill Street).

(484) Hickory Street, east side starting at a point 118 feet south of the southern curb line of Liberty Street and running 20 feet south therefrom (43 Hickory Street).

(485) Watsessing Avenue, east side starting at a point 218 feet north of the northern curb line of Westing House Plaza and running 20 feet west therefrom (32 Watsessing Ave.).

(486) Floyd Avenue, south side starting at a point 240 feet west of the western curb line of Ampere Parkaway and running 20 feet west therefrom (16 Floyd Avenue).

(487) Park Avenue, south side starting at a point 141 feet west of the southern curb line of Park Avenue and running 20 feet west therefrom (10 Park Ave. Apt. 1).


(488) Franklin Street, south side at a point 38 feet west of the westerly curb line of Berkeley Avenue and running 20 feet west therefrom (147 Franklin Ave.).

Section 2. All ordinances inconsistent herewith are hereby repealed.

Section 3. This ordinance shall take effect upon final passage and publication in accordance with the law.
