2015 RESOLUTION APPOINTMENT

EMERGENCY MEDICAL DISPATCHER/TELECOMMUNICATOR - KOUKOULIS

WHEREAS, Director DeMaio recommends that Pantelis Koukoulis of Bloomfield be appointed to the position of Emergency Medical Dispatcher/Telecommunicator effective March 3, 2015; and

WHEREAS, the Director of Finance has certified that funding is available for this position.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey that Pantelis Koukoulis is hereby appointed to the position of Emergency Medical Dispatcher/Telecommunicator for the Bloomfield Police Department, effective March 3, 2015, at step 1 of the negotiated salary contained in the Collective Bargaining Agreement in effect for such position; and

BE IT FURTHER RESOLVED, that this appointment is subject to the Bloomfield Township Town Code Chapter 88 Residency Requirements, which requires the employee to be a bona fide resident of the Township of Bloomfield and to maintain such a residency and failure of any such employee to maintain residency in the Township of Bloomfield shall cause for removal and discharged from employment.
