THIS AGREEMENT, entered into this day of 2015 by and between the BOROUGH OF NORTH ARLINGTON, a Municipal Corporation of the State of New Jersey, having its principal offices at 214 Ridge Road, North Arlington, New Jersey, hereinafter referred to as "Borough" of North Arlington and _____, hereinafter referred to as the "USER".

WITNESSETH:

That for and in consideration of the sum agreed upon each to the other in hand paid at or before the execution and delivery of this Agreement the receipt whereof is mutually acknowledged, the parties hereto do covenant and agree as follows:

1. The Borough of North Arlington, through its Police Department, will allow and permit the "USER" the use of the Police Pistol Range, located in the Hackensack Meadowlands/Borough of North Arlington, New Jersey.
2. The Police Department of the Borough of North Arlington and the "USER" will be permitted to utilize the Range facilities so as not to interfere with normal Police Department training.
3. The Borough of North Arlington, through its Police Department, agrees that there will not be any representative of the North Arlington Police Department in attendance during usage of the Range and the "USER" will supply supervision at its sole expense to oversee the adherence to safety rules.
4. The "USER" agrees to provide a qualified Range Officer and instructors during all training sessions for said agency.
5. The "USER" agrees that only agency approved service load or equivalent load ammunition appropriate for use in New Jersey State mandated qualification courses will be used during training. Said ammunition will not be armor piercing or tracer type.
6. The "USER" agrees that they will supply their own ammunition, targets, weapons, and cleaning supplies.

7. The "USER" agrees to indemnify and hold harmless the Borough of North Arlington, its agents, servants and employees from and against all claims, damages, losses, and expenses resulting in bodily injury or death or damage to tangible property due to the negligence of the "USER", its agents, servants, and employees acting within the scope of their employment.

8. The "USER" agrees to indemnify and hold harmless the Hackensack Meadowlands Development Commission, its agents, servants, and employees from and against all claims, damages, losses and expenses resulting in bodily injury or death or damage to tangible property due to the negligence of the "USER", its agents, servants, and employees acting within the scope of their employment.


