Cataldo is hereby-appointed Clerk for the Finance Department for the Township of Bloomfield at the first Step of the salary guide for Clerk as set forth in the ordinance for that position; and

BE IT FURTHER RESOLVED, that this appointment is subject to the Bloomfield Township Code Chapter 88 Residency Requirements, which requires the employee to be a bona fide resident of the Township of Bloomfield and to maintain such residency and failure of any such employee to maintain residency in the Township of Bloomfield shall cause for removal and discharged from employment.
