**2015 RESOLUTION SALARY ADJUSTMENT**

**SALARY ADJUSTMENT DETECTIVE**

WHEREAS, on September 15, 2014, Police Officer Michael Mora was assigned to the Detective Bureau; and

WHEREAS, based upon Officer Mora's assignment to the Detective Bureau and in accordance with the applicable Collective Bargaining Agreement it is necessary to adjust Officer Mora's salary effective December 22, 2014.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor of Council of the Township of Bloomfield, County of Essex, State of New Jersey, hereby directs the Finance Director to adjust the salary of Officer Mora in accordance with the salary ordinance in effect for a police officer assigned to perform the duties of a detective within the Bloomfield Police Department; and

BE IT FURTHER RESOLVED, that the Finance Director shall ensure that Officer Mora receives Detective pay for as long as he remains assigned to the position of detective; and

BE IT FURTHER RESOLVED, that the Police Director is hereby directed to notify the Finance Director if Officer Mora is reassigned and ceases to perform the duties of Detective at which time the Finance Director is directed to alter his pay as necessary.
