WHEREAS, after the required legal advertising was published, sealed bids were received in the Council Chambers of the Municipal Building, Bloomfield, New Jersey on March 24, 2015 by the Purchasing Committee of the Township of Bloomfield in accordance with N.J.S.A. 40A:11-1 et seq., "Local Public Contracts Law" for The Clarks Pond South Athletic Field Lighting Project; and

WHEREAS, a total of two (2) bids were received and were referred to the Township Engineer for review; and



WHEREAS, after review of the bid, the Township Engineer hereby recommends that the contract be awarded to Margonis Electrical Contracting, 163 Midland Avenue, Garfield, New Jersey 07026 for a total contract amount of \$155,000.00; and

WHEREAS, the Director of Finance has indicated that funding is available through a grant from the Essex County Open Space Program and within the capital budget of the Recreation Department.
