2015 RESOLUTION AWARD OF CONTRACT

AWARD OF CONTRACT - FELTON FIELD SOIL REMEDIATION PROJECT

WHEREAS, the Director of Finance has indicated that funding is available in Capital Account #C-04-55-877-947.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey hereby accepts the recommendation of the Township Engineer and he may enter into a contract for the above project with The Ambient Group, LLC, 222 Thies Road, Sewell, New Jersey 08080 in the amount of \$119,060.00.
