2015 RESOLUTION APPROVAL

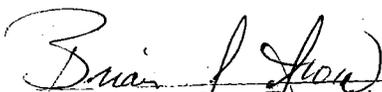
WHEREAS, Deborah Washington recognizes that the Civil Service Commission may call for a test for this position and/or generate a list of eligible candidates, and if she does not take the test, or if she does take the test and she does not appear in the top three spots on a list of eligible candidates, or if she does appear in the top three spots and is not selected for the position, in the sole direction of the Township she may be removed from her employment with the Township or be moved back to the position of Clerk and her salary will be adjusted accordingly; and

WHEREAS, the Chief Judge of Bloomfield Municipal Court recommends that Deborah Washington be appointed to the position of Assistant Violation Clerk; and

WHEREAS, the Finance Director has certified that funds are available to make this provisional promotion.

NOW, THEREFORE BE IT RESOLVED, that Deborah Washington is hereby appointed to the position of Assistant Violation Clerk for the Bloomfield Municipal Court, effective May 5, 2015 in accordance with the terms and conditions of this resolution.
