WHEREAS, Tashawya D. Miles appears on the list of eligible candidates; and

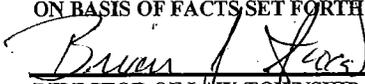
WHEREAS, the Township's Administrator recommends appointing Tashawya D. Miles to the position of Deputy Court Administrator; and
