2015 RESOLUTION AWARD OF CONTRACT

2015 CDBG SPRING TREE PLANTING PROGRAM

WHEREAS, after the required legal advertising was published, sealed bids were received in the Council Chambers of the Municipal Building, Bloomfield, New Jersey on May 6, 2015 by the Purchasing Committee of the Township of Bloomfield in accordance with N.J.S.A. 40A:11-1 et seq., "Local Public Contracts Law" for the 2015 CDBG Spring Tree Planting Program; and

WHEREAS, the bids received were referred to the Township Engineer for review; and

WHEREAS, a total of five bids were received with the lowest bid submitted by Louis Barbato Landscaping, LLC, 1600 Railroad Avenue, Holbrook, New York 11714 in the amount of \$23,870.00; and

WHEREAS, the bid package submitted by Louis Barbato Landscaping, LLC was found to be complete and responsive; and

WHEREAS, after consideration by the Township Engineer it is recommended that the contract be awarded to Louis Barbato Landscaping, LLC, 1600 Railroad Avenue, Holbrook, New York 11714 in the amount of \$23,870.00; and

WHEREAS, the Director of Finance has indicated that funding is available in CDBG Capital Account B-19-14-415-028.

NOW THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey hereby accepts the recommendation of the Township Engineer and he may enter into a contract for the above tree planting program with Louis Barbato Landscaping, LLC, 1600 Railroad Avenue, Holbrook, New
