2015 RESOLUTION ABC TRANSFERS

ALCOHOLIC BEVERAGE RESOLUTION - PERSON-TO-PERSON AND PLACE-TO-PLACE TRANSFER OF LICENSE #0702-33-025-009

WHEREAS, the New Jersey State Department of Treasury, Division of Taxation (the "Division") authorized the conduct of a public auction in connection with Plenary Retail Consumption License #0702-33-025-009 (the "License") previously held by DEP Lounge, Inc., t/a Prana Restaurant & Lounge ("DEP") and seized for unpaid State taxes; and

WHEREAS, on October 15, 2014, the Division conducted such public auction in the Township of Bloomfield (the "Township"); and

WHEREAS, at such auction, Nevada Diner-Restaurant Corp., having an address at 293 Broad Street, Bloomfield, New Jersey, 07003 ("Nevada") submitted a bid; and


WHEREAS, the Division awarded the purchase of the License to Nevada, subject to the approval by the Township of the transfer of the License from DEP to Nevada; and

WHEREAS, J&A Diner Corporation, t/a Nevada Diner submitted an application to the Municipal Clerk seeking approval of the transfer of the License from DEP to Nevada, along with the appropriate application fee; and

WHEREAS, the submitted application form is complete in all respects, the transfer fees have been paid, and the license has been properly renewed for the current license term; and

WHEREAS, the applicant is qualified to be licensed according to all standards established by Title 33 of the New Jersey statutes, regulations promulgated thereunder, as well as pertinent local ordinances and conditions consistent with Title 33; and



WHEREAS, the approval granted hereunder is for a person-to-person and place-to-place transfer.


