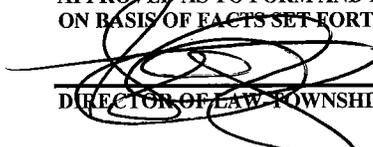
RENEWAL OF PLENARY RETAIL CONSUMPTION LICENSES WITH BROAD C PACKAGE PRIVILEGES
