2015 RESOLUTION CHANGE ORDERS

NORTH CENTER STREETScape IMPROVEMENTS - CHANGE ORDER NO. 1 - FINAL

WHEREAS, the Township of Bloomfield entered into a contract for the North Center Streetscape Improvements with J.C. Contracting, Inc., 25 Orange Street, Bloomfield, NJ 07003 (hereinafter "the Contractor"); and

WHEREAS, during the course of construction, unforeseen surface and subsurface conditions were encountered during construction that required change in the scope of the work; and

WHEREAS, the contractor provided Change Order No. 1 - Final for an increase in the contract amount of \$177,600.74; and

WHEREAS, the Township Engineer has reviewed cost associated with Change Order No. 1 - Final and recommends the Change Order be approved; and

WHEREAS, Change Order No. 1 - Final represents an increase in the cost of the contract in the amount of \$177,600.74 or 19%; and

WHEREAS, the Mayor and Council, based on the recommendation of the Township Engineer is satisfied that the Change Order No. 1 - final should be approved; and

WHEREAS, this Change Order was found to be beneficial and necessary; and

WHEREAS, the Director of Finance has certified that the funds are available within Capital Account #C-04-55-862-966.

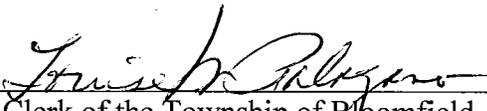
