2015 RESOLUTION AWARD OF CONTRACT

**AWARD OF CONTRACT - REPLACEMENT OF ROOFS AT BLOOMFIELD
FIREHOUSE NUMBERS 4, 2 AND 3**

WHEREAS, after the required legal advertising was published, sealed bids were received in the Council Chambers of the Municipal Building, Bloomfield, New Jersey on July 8, 2015 by the Purchasing Committee of the Township of Bloomfield in accordance with N.J.S.A. 40A:11-1 et seq., "Local Public Contracts Law" for the Replacement Of Roofs At Bloomfield Firehouse Numbers 4, 2 And 3; and

WHEREAS, a total of six (6) bids were received and were referred to the Township Engineer and Engineering Consultant for review; and

WHEREAS, the responsive, low bidder was determined to be Build Rite, LLC, 16 Darlington Avenue, Wayne, New Jersey 07470 in the amount of \$388,595.00; and

WHEREAS, after review of the bids, and upon recommendation by the project consultant, Remington & Vernick Engineers, the Township Engineer hereby recommends that the contract be awarded to the lowest, responsive bidder, Build Rite, LLC, 16 Darlington Avenue, Wayne, New Jersey 07470 in the amount of \$388,595.00; and

WHEREAS, the Director of Finance has indicated that funding is available within Township Capital Account #C-04-55-877-947 and #C-04-55-705-947.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey hereby accepts the recommendation of the Township Engineer and he may enter into a contract for the above work with Build Rite, LLC, 16 Darlington Avenue, Wayne, New Jersey in the amount of \$388,595.00.
