2015 RESOLUTION APPOINTMENT

PUBLIC SECTOR JOINT INSURANCE FUND

NON-BINDING RESOLUTION OF INTENT TO JOIN

WHEREAS, a number of local governmental units in various parts of the State of New Jersey have joined together to form a Joint Insurance Fund as permitted by N.J.S.A. 40A:10-36; and

WHEREAS, there has been discussion regarding the formation of a PUBLIC SECTOR JOINT INSURANCE FUND (PSJIF) for local governmental units;

WHEREAS, the statutes and regulations governing the creation and operation of a Joint Insurance Fund contain elaborate restrictions and safeguards concerning the safe and efficient administration of the public interest entrusted to such a Fund; and

WHEREAS, the Governing Body of the Township of Bloomfield has determined that membership in the PSJIF would be in the best interest of itself and its citizens.

NOW, THEREFORE BE IT RESOLVED, that the Governing Body of the Township of Bloomfield does hereby resolve that the Township of Bloomfield intends to become a member of the PSJIF for the purpose of establishing the following types of coverage:

1. Workers' compensation and employers' liability;
2. General liability including law enforcement;
3. Motor vehicle liability; and
4. Property damage (buildings, contents, equipment and motor vehicles);

BE IT FURTHER RESOLVED, that such membership is subject to the right to accept the terms of membership when the same is received from the PSJIF; and

APPROVED AS TO FORM AND PROCEDURE ON
BASIS OF FACTS SET FORTH

DIRECTOR OF LAW - TOWNSHIP ATTORNEY

BE IT FURTHER RESOLVED, that such membership is subject to the right to accept the Bylaws and Initial Assessment of the PSJIF, as approved and adopted pursuant to N.J.S.A. 40A:10-39, when the same is received from the PSJIF.
