**EXTENSION TEMPORARY STAFF - BLOOMFIELD MUNICIPAL COURT**

**WHEREAS**, on February 9, 2015 the Mayor and Council passed a resolution to hire Leona Carribon-Baptiste as a part time temporary employee; and

**WHEREAS**, Leona Carribon-Baptiste has indicated a willingness to extend her employment at an hourly rate of \$15.00 per hour; and

**WHEREAS**, the Court Administrator and Township Administrator recommends extending Leona Carribon-Baptiste appointment as a part time temporary employee; and

**WHEREAS**, Leona Carribon-Baptiste recognizes that she will not receive health benefits as a part time temporary employee and she shall not work more than 20 hours per week; and

**WHEREAS**, the Director of Finance has indicated that funding is available for this position.

**NOW, THEREFORE, BE IT RESOLVED**, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, that Leona Carribon-Baptistes' employment is hereby extended at the rate of \$15.00 per hour, not to exceed 20 hours per week; and

**BE IT FURTHER RESOLVED**, that this temporary appointment will terminate August 28, 2015 without any further action by the Mayor and Council.
