**NOW, THEREFORE, BE IT RESOLVED**, by the Mayor and Council of the Township of Bloomfield, Essex County, State of New Jersey, as follows:

1. The Township of Bloomfield hereby declares that the obsolete vehicles and equipment are not needed for public use.
2. The Township of Bloomfield, its officers and attorney, are hereby authorized and directed to take any and all steps necessary to proceed with a public sale of said vehicles and equipment.
3. A notice of the date, time and place of the public sale together with a description of said obsolete vehicles and equipment parts and conditions of sale, shall be published in the Bloomfield Life with the sale being held not less than seven (7) nor more than fourteen (14) days after publication of said notice. The vehicles will be sold to the highest bidder above the minimum bid price.
4. No limit shall be placed on the numbers of vehicles and equipment that can be purchased by any one bidder.
5. This resolution shall take effect immediately.
