**2015 RESOLUTION SALARY ADJUSTMENT**

**SALARY ADJUSTMENT DETECTIVE - MALDONADO**

**WHEREAS**, on March 27, 2015, Police Officer Shonah Maldonado was assigned to the Detective Bureau; and

**WHEREAS**, based upon Officer Maldonado's assignment to the Detective Bureau and in accordance with the applicable Collective Bargaining Agreement it is necessary to adjust Officer Maldonado's salary effective July 24, 2015.


**NOW, THEREFORE, BE IT RESOLVED**, that the Mayor of Council of the Township of Bloomfield, County of Essex, State of New Jersey, hereby directs the Finance Director to adjust the salary of Officer Maldonada in accordance with the salary ordinance in effect for a police officer assigned to perform the duties of a detective within the Bloomfield Police Department; and

**BE IT FURTHER RESOLVED**, that the Finance Director shall ensure that Officer Maldonado receives Detective pay for as long as she remains assigned to the position of detective; and

**BE IT FURTHER RESOLVED**, that the Police Director is hereby directed to notify the Finance Director if Officer Horn is reassigned and ceases to perform the duties of Detective at which time the Finance Director is directed to alter her pay as necessary.
