**2015 RESOLUTION BUDGETS**

**PROVIDING FOR THE INSERTION OF SPECIAL ITEMS OF REVENUE AND  
APPROPRIATION IN THE BUDGET CHAPTER 159/2**

---

**WHEREAS**, N.J.S.A. 40A:4-87 provides that the Director of the Division of Local Government Services may approve the insertion of any special item of revenue in the budget of any municipality when such item shall have been made available by law and the amount thereof was not determined at the time of the adoption of the budget; and

**WHEREAS**, said Director may also approve the insertion of any items of appropriation for equal amount; and


**WHEREAS**, after the 2015 budget was adopted, the Township of Bloomfield became informed of the availability of revenue in the amount of \$16,000.00 from the PSF - Pedestrian Safety, Education and Enforcement Fund - Account # 5-01-08-333-000.

**NOW, THEREFORE, BE IT RESOLVED**, that the Township of Bloomfield hereby requests the Director of the Division of Local Government Services to approve the insertion of an item of revenue in the Budget of the year 2015 in the sum of \$16,000.00 as an anticipated revenue from the PSF Pedestrian Safety, Education and Enforcement Fund - Account # 5-01-08-333-000; and

**BE IT FURTHER RESOLVED**, that a like sum of \$16,000.00 be and the same is hereby appropriated under the Budget of the Township of Bloomfield for the State FY2016 Bloomfield Pedestrian Safety Grant - Account #5-01-40-321-000; and

**BE IT FURTHER RESOLVED**, that this resolution be filed with the Director of the Division of Local Government Services, Department of Community Affairs.
