**2015 RESOLUTION AWARD OF CONTRACT**

**PAYMENT AGREEMENT WITH THE COUNTY OF ESSEX IN THE AMOUNT UP TO \$142,120.00 FOR THE INSTALLATION OF BLACK, POWDER-COATED TRAFFIC SIGNALS AT THE INTERSECTIONS OF BROAD STREET AND PITT STREET AND BROAD STREET AND BALDWIN STREET**

**WHEREAS**, the traffic signals located at the intersection of Broad Street at Pitt Street and Broad Street at Baldwin Street are owned and operated by the County of Essex; and

**WHEREAS**, the Township of Bloomfield desires to replace these signals with black, powder-coated signals and posts to enhance the streetscape improvements previously completed along Broad Street at these locations; and

**WHEREAS**, the Township Engineer requested of the County Engineer the cost for Essex County to install these new signals and posts; and

**WHEREAS**, County Engineer provided a total cost up to \$142,120.00 to perform the installation and upgrade; and

**WHEREAS**, the Township Engineer reviewed these costs and found them to be reasonable related to the work to be performed by the County; and

**WHEREAS**, the upgraded traffic signals will be beneficial to Township; and

**WHEREAS**, the Director of Finance has indicated that funding is available in the Township's Capital Roadway Program Account Numbers C-04-55-703-965 and C-04-55-873-965.

**NOW, THEREFORE, BE IT RESOLVED**, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, hereby authorize the Township Engineer to make payment up to, and not to exceed \$142,120.00 to the County of Essex for the installation of upgraded, black powder-coated traffic signals and posts at the intersections of
