2015 RESOLUTION REJECTION OF BIDS

2015 CAPITAL ROADWAY PROGRAM - CONTRACT A - REJECT AND RE-BID

WHEREAS, after the required legal advertising was published, sealed bids were received in the Council Chambers of the Municipal Building, Bloomfield, New Jersey on August 15, 2015 by the Purchasing Committee of the Township of Bloomfield in accordance with N.J.S.A. 40A:11-1 et seq., "Local Public Contracts Law" for the 2015 Capital Roadway Program - Contract A; and

WHEREAS, the bids received were referred to the Project Consultant, Remington & Vernick Engineers and Township Engineer for review; and

WHEREAS, a total of two (2) bids were received with one of the bids submitted by Stanziale Construction, Bloomfield, New Jersey being unresponsive and the second bid submitted by Cifelli & Son General Contractors, Inc., Nutley, New Jersey exceeding the Engineer's estimate; and

WHEREAS, it is the recommendation of the project consultant and the Township Engineer that all bids be rejected and the project re-bid in an effort to receive more responsive bids for this project.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey hereby authorize the rejection of all bids for 2015 Capital Roadway Program - Contract A and that the Township Engineer be authorized to re-advertise and re-bid the contract.
