2015 RESOLUTION EMPLOYEES

PART TIME DPW MAINTENANCE WORKER

WHEREAS, the Township of Bloomfield Department of Works and Parks needs to one part-time DPW Mechanic on an emergency interim basis; and

WHEREAS, Angelo Charles Coccoziello is a Bloomfield resident; and

WHEREAS, Mr. Coccoziello will be paid at a rate of \$25.00 per hour and shall not work more than 15 hours per week, will not be entitled to work overtime and will not receive health benefits as a temporary employee; and

WHEREAS, the Director of Finance has indicated that funding is available for this position.


NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey hereby hire the above reference employee as part-time temporary DPW Maintenance Worker employee starting on or about September 1, 2015.

BE IT FURTHER RESOLVED, that this appointment is subject to the Bloomfield Township Code Chapter 88 Residency Requirements, which requires the employee to be a bona fide resident of the Township of Bloomfield and to maintain such residency and failure of any such employee to maintain residency in the Township of Bloomfield shall cause for removal and discharged from employment.

BE IT FURTHER RESOLVED, that this temporary appointment will terminate December 31, 2015 without any further action by the Mayor and Council.
