BLOOMFIELD BUY RITE - LIQUOR STORE - 35 LACKAWANNA PLACE

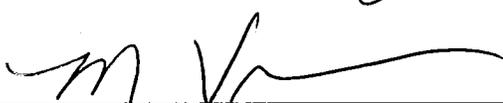
NOW, THEREFORE BE IT RESOLVED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, that in accordance with Chapter 122, Alcoholic Beverages, Article I, General Regulations, Section 122-14, Distance between licensed premises, the Mayor and Council of the Township of Bloomfield find that there is no undue concentration of establishments of the type to be relocated in the immediate area, the proposed location of the Bloomfield Buy Rite, LLC, for a transfer of a plenary retail consumption license to 35 Lackawanna Avenue, a part of Block 228 Redevelopment Project, is appropriate for the type of operation anticipated, and for the reasons set forth on the record, the Township hereby waives the 500 foot distance for this liquor license transfer; and

BE IT FURTHER RESOLVED, that the Township Clerk is hereby directed to process said request for transfer of a liquor license to that location applying the Township's waiver of the 500 foot distance between licensed premises.

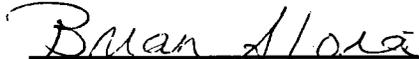
