2015 RESOLUTION CHANGE ORDERS

2015 RESOLUTION - 2011-2012 CAPITAL ROADWAY PROGRAM - CONTRACT 2 - CHANGE ORDER NO. 1 - FINAL

WHEREAS, the Township of Bloomfield entered into a contract for the 2011-2012 Capital Roadway Program - Contract 2 with D.L.S. Contracting, Inc., 633 Franklin Avenue, Suite 170, Nutley, New Jersey 07110 (hereinafter "the Contractor"); and

WHEREAS, during the course of construction, additional work was requested including repair and resurfacing of six short sections of roadway that had severely deteriorated as well as adjustment to various contract quantities to meet existing, as-built conditions; and

WHEREAS, Change Order No. 1 - Final represents an increase in the cost of the contract in the amount of \$51,901.43 or 7.57%; and

WHEREAS, the Mayor and Council, based on the recommendation of the Township Engineer is satisfied that the Change Order should be approved; and

WHEREAS, this Change Order was found to be beneficial and necessary; and

WHEREAS, the Chief Financial Officer certifies that funding is available within the various township roadway capital accounts

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey that Change Order No. 1 - Final is hereby approved and the Financial Officer of the Township of Bloomfield is hereby authorized to adjust payment for this work.
