2015 RESOLUTION AWARD OF CONTRACT

AWARD OF CONTRACT FOR WATER SYSTEM FITTINGS & SUPPLIES - H.D. SUPPLY WATERWORKS, LTD

WHEREAS, after the required legal advertising was published, sealed bids were received in the Council Chambers of the Municipal Building, Bloomfield, New Jersey on July 22, 2015 by the Purchasing Committee of the Township of Bloomfield in accordance with N.J.S.A. 40A:11-1 et seq., "Local Public Contracts Law" for Water System Fittings & Supplies; and

WHEREAS, a single bid was received from H.D. Waterworks , LTD, 61 Gross Avenue, Edison, New Jersey 08837 and referred to the Township Engineer for review; and

WHEREAS, after review of the bid, the Township Engineer determined that the unit prices provided were consistent with current market rates and hereby recommends that the contract be awarded to H.D. Waterworks , LTD, 61 Gross Avenue, Edison, New Jersey 08837 for a total price of \$48,889.60; and

WHEREAS, the Director of Finance has indicated that funding is available in the Township water utility.

NOW THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey hereby accepts the recommendation of the Township Engineer and he may enter into a contract with H.D. Waterworks , LTD, 61 Gross Avenue, Edison, New Jersey 08837 for a total price of \$48,889.60
