2015 RESOLUTION AWARD OF PROFESSIONAL SERVICE

AUTHORIZING THE AWARD OF A FAIR AND OPEN CONTRACT FOR THE PREPARATION OF DESIGN PLANS, SPECIFICATIONS, BID ASSISTANCE AND CONSTRUCTION ADMINISTRATION FOR THE RENOVATIONS OF THE COURT AND VIOLATIONS BUREAU

WHEREAS, the Township of Bloomfield has a need to acquire professional services for preparation of design plans, specifications, bid assistance and construction administration for the renovations of the court and violations department; and

WHEREAS, the Township desires to make this appointment under the provisions of *N.J.S.A. 19:44A-20.4*, as a fair and open contract; and

WHEREAS, the Township Engineer has determined that the value of these services may exceed \$17,500.00; and

WHEREAS, this contract will end upon the completion of the project; and;

WHEREAS, on July 15, 2014 a total of three, sealed proposals were received and were opened by the purchasing committee proposals; and

WHEREAS, after review of all the consultants qualifications, including price, past work experience and completeness of the proposal submission, it was the recommendation of the Township Engineer that a contract for professional services be awarded to The Goldstein Partnership (the Professional), 515 Valley Street, Suite 110, Maplewood, New Jersey 07040 for a total contract price not to exceed \$39,500.00.

WHEREAS, the Professional has completed and submitted a Business Entity Disclosure Certification which certifies they have not made any reportable contributions to a political or candidate committee in the Township of Bloomfield in the previous one year and that the contract will prohibit the Professional from making any reportable contributions during the term

WHEREAS, the Director of Finance has certified that funds are available to cover the cost of these services within Capital Account # C-04-55-705-947.

NOW, THEREFORE, BE RESOLVED that the Mayor and Council of the Township of Bloomfield authorizes the Township Engineer to enter into a contract with the Professional as described herein; and

BE IT FURTHER RESOLVED, that no minimum payment is implied or guaranteed; and

BE IT FURTHER RESOLVED, that the Business Entity Disclosure Certification, the Township Engineer's Determination of Value, the proposal of the Professional and the contract itself be placed on file with this resolution; and

BE IT FURTHER RESOLVED, that the above documents shall be available for public inspection at the office of the Township Clerk during regular business hours; and

BE IT FURTHER RESOLVED, that Township reserves the right to cancel this contract upon thirty (30) days notice and the Professional shall only be paid for the work completed on a pro-rated amount if the contract calls for a monthly retainer; and

BE IT FURTHER RESOLVED, that a notice of this action shall be printed once in the official newspaper of the Township of Bloomfield.
