2015 RESOLUTION AWARD OF CONTRACT

2015 CAPITAL ROADWAY PROGRAM - CONTRACT A

WHEREAS, after the required legal advertising was published, sealed bids were received in the Council Chambers of the Municipal Building, Bloomfield, New Jersey on September 9, 2015 by the Purchasing Committee of the Township of Bloomfield in accordance with N.J.S.A. 40A:11-1 et seq., "Local Public Contracts Law" for the 2015 Capital Roadway Program - Contract A; and

WHEREAS, a total of four (4) bids were received and were referred to the Township Engineer for review; and

WHEREAS, the low bidder was Smith-Sondy Asphalt Construction Corp., 150 Anderson Avenue, Wallington, NJ 07057 at a total bid amount of \$1,067,411.00; and

WHEREAS, after review of the bid, the Township Engineer hereby recommends that the contract be awarded to Smith-Sondy Asphalt Construction Corp., 150 Anderson Avenue, Wallington, NJ 07057 at a total bid amount of \$1,067,411.00; and

WHEREAS, the Director of Finance has indicated that funding is available in the Township's Capital Roadway Program Account Numbers C-04-55-703-965.
