
WHEREAS, Cheryl Epple recognizes that she will not receive health benefits and the work week is a maximum of 20 working hours; and

WHEREAS, the Director of Finance has certified that funding is available to cover the cost of this appointment.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey that Cheryl Epple is hereby-appointed as a part-time clerk in the Bloomfield Municipal Court for the Township of Bloomfield at the first step of the salary guide for clerk as set forth in the ordinance for that position effective November 3, 2015; and

BE IT FURTHER RESOLVED, that this appointment is subject to the Bloomfield Township Code Chapter 88 Residency Requirements, which requires the employee to be a bona fide resident of the Township of Bloomfield and to maintain such residency and failure of any such employee to maintain residency in the Township of Bloomfield shall cause for removal and discharged from employment.
