2015 RESOLUTION APPOINTMENT

APPOINTMENT COURT ADMINISTRATOR

WHEREAS, the Township of Bloomfield needs a Municipal Court Administrator in the Municipal Court to perform all of the duties and responsibilities set forth in the Charter of the Township of Bloomfield, its by-laws, ordinances and laws of the State of New Jersey; and

WHEREAS, the current Municipal Court Administrator has resigned from that position effective October 7, 2015; and

WHEREAS, pursuant to Court Rule 1:34-3 requires that the Township follow a hiring process for the position of Municipal Court Administrator; and

WHEREAS, applications were received by the Township of Bloomfield for the position of Municipal Court Administrator; and

WHEREAS, the applications were reviewed by the Essex County Court Staff, Bloomfield Chief Judge and the Township Administrator; and

WHEREAS, one applicant had the qualifications that the Township of Bloomfield was searching for; and

WHEREAS, no Certified Court Administrators that reside in Bloomfield have applied for this position; and

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey that Claudia Santos be and is hereby appointed Municipal Court Administrator effective November 23, 2015 at step 3 in the salary ordinance of the Township of Bloomfield for that position.
