2015 RESOLUTION APPROVAL

PURCHASE FOR THE BLOOMFIELD FIRE DEPARTMENT

WHEREAS, the Township of Bloomfield needs to repair a fire apparatus; and

WHEREAS, the Township of Belleville has a decommissioned fire apparatus that the Township of Bloomfield can purchase for parts; and

WHEREAS, the Township of Bloomfield will substantially reduce the cost of the repair to Bloomfield's fire apparatus by purchasing the Belleville decommissioned fire apparatus and using its parts; and

WHEREAS, the Township of Bloomfield Fire Chief and the Township Administrator recommend that the Township of Bloomfield purchase Belleville's decommissioned fire apparatus for the purpose described herein.

NOW, THEREFORE BE IT RESOLVED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, that the Township Administrator and the Fire Chief are hereby authorized to purchase Belleville's decommissioned fire apparatus; and

BE IT FURTHER RESOLVED, that after the necessary parts are removed from the Belleville decommissioned fire apparatus, the Township Administrator and the Fire Chief are authorized to take any necessary action to resell Belleville's decommissioned fire apparatus recognizing that the apparatus will be of no further use to the Township of Bloomfield.
