2015 RESOLUTION ABC TRANSFERS

ABC PLENARY RETAIL CONSUMPTION LICENSE - RENEWAL PURSUANT TO SPECIAL RULING - 3 ON THE ROCKS, INC.

WHEREAS, the licensee failed to renew its Plenary Retail Consumption License for the 2008-2009, 2009-2010, 2010-2011, 2011-2012, 2012-2013, 2013-2014, 2014-2015, Licensing Term in a timely fashion for premises located at 201-203 Bloomfield Avenue, Bloomfield, New Jersey; and

WHEREAS, the Licensee filed a Verified Petition for Relief pursuant to N.J.S.A. 33:1-12.18 and a Special Ruling was received July 23, 2015; and

WHEREAS, said Special Ruling authorized the Mayor and Council of the Township of Bloomfield to consider the application for a new license for failure to timely renew said License for the terms referenced above; and

WHEREAS, the Licensee subsequently filed for renewal terms as required by the Special Ruling; and

WHEREAS, all required fees have been received and paid through the 2015-2016 licensing terms and the appropriate Tax Clearance Certificates have been received as required by the Special Ruling from the Division of Taxation for the State of New Jersey.
