**2015 RESOLUTION CHANGE ORDERS**

**ROOF REPLACEMENT AT BLOOMFIELD LAW ENFORCEMENT BUILDING -  
CHANGE ORDER NO. 1 - FINAL**

WHEREAS, the Township of Bloomfield entered into a contract for the replacement of the roof at the Bloomfield Law Enforcement Building with Northeast Roof Maintenance, 649 Catherine Street, Perth Amboy, NJ 08861 (hereinafter "the contractor"); and

WHEREAS, during the course of the project, as certain rooftop features were uncovered and inspected, changes to the project scope were required; and

WHEREAS, the changes resulted in a net decrease to the contract price of \$11,084.00 thereby resulting in a final contract price of \$147,066.00; and

WHEREAS, the Township Engineer has reviewed the changes and recommends that they be accepted; and

WHEREAS, the Mayor and Council, based on the recommendation of the Township Engineer is satisfied that the specified changes should be approved; and


WHEREAS, this Change Order was found to be beneficial and necessary.
