2015 RESOLUTION APPOINTMENT

ANIMAL SHELTER APPOINTMENT - ESCOBAR

WHEREAS, a part-time position presently exists in the Bloomfield Animal Shelter; and

WHEREAS, Henry Escobar has indicated a desire to fill this position; and

WHEREAS, the Mayor and Council of the Township of Bloomfield have determined that it is in the best interest of the Township of Bloomfield to appoint Henry Escobar has, of Cedar Grove, New Jersey as a part-time animal shelter employee in the Bloomfield Animal Shelter; and

WHEREAS, Henry Escobar recognizes that he will not receive health benefits and the work week is a maximum of 25 working hours; and

WHEREAS, the Director of Finance has certified that funding is available to cover the cost of this appointment.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey that Henry Escobar is hereby-appointed as a part-time employee in the Bloomfield Animal Shelter at a rate of \$15 per hour effective _____, 2015; and

BE IT FURTHER RESOLVED, that notwithstanding Henry Escobar's employment start date, the Finance Director is hereby authorized to pay Henry Escobar for all hours worked in the animal shelter from November 5, 2015, forward as outlined in the Settlement Agreement between Bergen County Humane Enforcement and the Township of Bloomfield.
