**WHEREAS**, 28% of motor vehicle fatalities in New Jersey are alcohol-related; and

**WHEREAS**, an enforcement crackdown is planned to combat impaired driving; and

**WHEREAS**, the State of New Jersey, Division of Highway Traffic Safety, has asked law enforcement agencies throughout several counties to participate in the *Drive Sober Super Bowl Crackdown* project; and


**WHEREAS**, the project will involve increase impaired driving enforcement from January 28, 2014 to February 4, 2014; and
