**2014 RESOLUTION AWARD OF PROFESSIONAL SERVICE**

**AUTHORIZING THE AWARD OF A NON-FAIR AND OPEN CONTRACT FOR PROPRIETARY SOFTWARE AND EQUIPMENT FOR IN-CAR VIDEO AND VIDEO STORAGE**

**WHEREAS**, the Township of Bloomfield needs the services of a Software and Hardware Specialist; and

**WHEREAS**, the Township desires to make this appointment under the provisions *N.J.S.A. 19:44A-20.5*, as a non-fair and open contract; and

**WHEREAS**, the Police Department Technology Unit has determined that the value of these services may exceed \$17,500; and

**WHEREAS**, this contract will end on December 31, 2014; and


**WHEREAS**, Kustom Signal Inc., 9652 Lioret Blvd, KS 66219 (hereinafter "Professional") has submitted the attached proposal indicating that the Professional will provide the services at a cost not to exceed \$17,499.00; and

**WHEREAS**, Kustom Signal Inc., has completed and submitted the attached Business Entity Disclosure Certification which certifies that the Professional has not made any reportable contributions to a political or candidate committee in the Township of Bloomfield in the previous one year, and that the contract will prohibit Kustom Signal Inc. from making any reportable contributions through the duration of this contract; and

**WHEREAS**, the Director of Finance has certified that funds are available to cover the cost of this service.

**NOW, THEREFORE, BE RESOLVED**, that the Mayor and Council of the Township of Bloomfield authorizes the Police Department Technology Unit to enter into a contract with Kustom Signal Inc. as described herein; and

**BE IT FURTHER RESOLVED**, that the above documents shall be available for public inspection at the office of the Township Clerk during regular business hours; and

**BE IT FURTHER RESOLVED**, that in accordance with Standardized Submission Requirements the Township reserves the right to cancel this contract upon thirty (30) days notice and the Professional shall only be paid for the work completed or on a pro-rated amount if the contracts calls for a monthly retainer; and

**BE IT FURTHER RESOLVED**, that a notice of this action shall be printed once in the official newspaper of the Township of Bloomfield.


