2014 RESOLUTION POLICY

ACCEPTANCE & ADOPTION OF STANDARD OPERATING PROCEDURES (SOP) FOR LOCALLY ADMINISTERED FEDERAL AID PROJECTS

WHEREAS, the Township of Bloomfield is in the process of securing a grant in the amount of \$846,860.00 from the Federal Highway Administration for the improvements to the Six-Point Intersection; and

WHEREAS, one requirement of eligibility for securing the grant funding is that the Township create Standard Operating Procedures (SOP) for locally administered federal aid projects; and


WHEREAS, the Standard Operating Procedures shall describe various procedures needed to award consultant and construction contracts; administer the construction of the project and process payment to the consultants and construction contractor; and

WHEREAS, the Standard Operating Procedures, dated January 10, 2014 has been reviewed and approved by the New Jersey Department of Transportation, Local Aid Office on behalf of the Federal Highway Administration; and

WHEREAS, the Township Engineer presented the document entitled Standard Operating Procedures for Locally Administered Federal Aid Projects, dated January 10, 2014 to the Mayor and Council during the council conference meeting held on February 18, 2014.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey hereby accepts and adopts the document entitled Standard Operating Procedures for Locally Administered Federal Aid Projects, dated January 10, 2014 for use in administering all Federal Aid Projects.
