



2014 RESOLUTION AGREEMENTS

EMPLOYEE # 01841

WHEREAS, on or about December 4, 2013, employee #01841 was served with a preliminary notice of disciplinary action; and

WHEREAS, the Honorable Patrick J. Arre, J.S.C., ordered the Mayor and Council to consider the advice, guidance and opinion of the Township's Attorneys that reviewed the evidence and the charges contained in the preliminary notice of discipline and empowered and directed the Mayor and Council to make a determination regarding the potential settlement of the disciplinary charges filed and the discipline sought against employee #01841; and

WHEREAS, the Mayor and Council believe that the charges should be withdrawn and dismissed at this time; and

WHEREAS, the Township Administrator/Appropriate Authority has also given his recommendation and opinion that the charges be withdrawn and dismissed based upon his review of the evidence and facts of the case.

NOW, THEREFORE BE IT RESOLVED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, that the preliminary notice of discipline served upon employee #01841 is hereby withdrawn and dismissed; and

BE IT FURTHER RESOLVED, that Weiner Lesniak shall advise the Court as to the withdrawal and dismissal of charges and request the dismissal of the pending complaint for mootness; and

BE IT FURTHER RESOLVED, that Weiner Lesniak is hereby authorized to continue to work to obtain terms of a global settlement of all possible claims of employee #01841 for the Mayor and Council to consider resolving all issues related to this matter, including the payment
