2014 RESOLUTION RETIREMENT

AUTHORIZATION TO PROCESS AN INVOLUNTARY DISABILITY RETIREMENT APPLICATION

WHEREAS, the Township of Bloomfield has employee a Laborer in the Department of Public Works; and

WHEREAS, the Laborer is an active member of the PERS; and

WHEREAS, the Laborer has seventeen years and three months of PERS Service Credit, meeting the minimum service credit requirement of at least ten years for PERS members; and

WHEREAS, the Township is of the opinion that the Laborer is totally and permanently disabled and no longer can perform his or her assigned duties based on the documentation supplied by professionals retained by the Council; and

WHEREAS, the Township of Bloomfield is unable to provide an alternative to the PERS covered position with duties capable of being performed by said Laborer; and

WHEREAS, the Township Administrator has consented to the processing of the Involuntary Disability Retirement application.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey hereby authorizes the Administrator to process an Involuntary Disability Retirement application for the Laborer at its Department of Public Works Facility; and

BE IT FURTHER RESOLVED, that certified copies of this resolution shall be forwarded to all parties involved in the administration of this action.
