RESOLUTION OF THE MAYOR AND TOWNSHIP COUNCIL OF THE TOWNSHIP OF BLOOMFIELD IN THE COUNTY OF ESSEX AUTHORIZING SETTLEMENT OF THE 2012 AND 2013 TAX APPEALS ENTITLED 1018 BROAD STREET JOINT VENTURE V. TOWNSHIP OF BLOOMFIELD, DOCKET NOS: 009374-2012 AND 000191-2013 OF THE TAX ASSESSMENT OF BLOCK 934, LOT 44, KNOWN AS 1018 BROAD STREET, IN THE TOWNSHIP OF BLOOMFIELD, ESSEX COUNTY, NEW JERSEY
