2014 RESOLUTION AGREEMENTS

MOON PALACE AGREEMENT

WHEREAS, on or about November 27, 2013, Moon Palace, Inc. was served with a Notice of Charges alleging certain violations of their Liquor license; and

WHEREAS, Moon Palace had a hearing on Monday, March 17, 2014, regarding the allegations in the Notice of Charges; and

WHEREAS, Moon Palace has agreed to a thirteen day (13) suspension, this suspension shall be completed within sixty days of the resolution and shall be served as the following (1) one consecutive seven day suspension, three two days suspensions; and

WHEREAS, this establishment will close at midnight every night (this may be revisited by business owner upon application to the counsel after one year); and

WHEREAS, Moon Palace will have a reduction to a maximum of 140 person capacity, this may be revisited by the business owner upon application to the counsel after one year; and

WHEREAS, if the business owner decides to sell this liquor license any such conditions shall not be transferred to the new buyer.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, hereby agrees that Moon Palace's Liquor license 0702-33-020-005 is hereby suspended as stated in the above.

BE IT FURTHER RESOLVED, that the conditions described above are hereby placed on Moon Palace's Liquor license.
