2014 RESOLUTION APPOINTMENT

WATER METER READER

WHEREAS, the Director of Department of Public Works has indicated a need to hire a position of Water Meter Reader; and

WHEREAS, the civil service commission does not have list of eligible for this position and therefore the Township must point someone provisional; and

WHEREAS, Bassam Chalet has indicated that if provisionally appointed to Water Meter Reader that he will comply with all of the requirements to become permanently appointed to the position; and

WHEREAS, Bassam Chalet has agreed that if he does not get permanently appointed to the position of Water Meter Reader that his position with the Township will be terminated immediately; and

WHEREAS, Bassam Chalet recognizes that even if he complies with all the requirements to become permanently appointed to the position of Water Meter Reader the Mayor and Council may not permanently fill the position and as a provisional appointment the Mayor and Council can remove him from this position at any time; and

WHEREAS, the Director of Finance as indicated that funding is available for this position.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey that Bassam Chalet is hereby appointed as a provisional Water Meter Reader for the Township of Bloomfield effective April 8, 2014 at the first step of the established salary guide for that position in accordance with the terms of this resolution.
